









Established in 2015 through the Homeless Youth Act (2SSB 5404) to lead policy, funding, and practice efforts within the state system for addressing five (5) key components:


- Stable Housing

- Social & Emotional Well-Being












Our Statement on Racial Equity

- At Building Changes, we seek to hold ourselves accountable for addressing racism and discrimination. Black, Indigenous, and people
 of color disproportionately experience homelessness due to historical and systemic racism. We cannot address homelessness
 without addressing racism at its roots and the trauma it continues to perpetuate. We set universal goals to end homelessness and
 pursue targeted solutions to achieve these goals.
- Our racial equity work does not stop there. We are committed to building an internal culture that challenges racism within our organization.





Homeless Student Stability Program

Established in 2016 to provide educational stability by promoting housing stability to students in the public K-12 system and their families experiencing homelessness, this includes unaccompanied youth.

Chapter RCW 43.185C Homeless Housing and Assistance authorizes these funds and RCW 43.185C.340 establishes the HSSP grant.



The Homeless Student Stability Program (HSSP) intends to fund organizations to



- Provide housing navigation, housing resources, and/or housing stability supports to alleviate and end housing crisis for students, unaccompanied youth and/or young adults, and families in the K-12 public school system.
- Develop partnerships with one or more school buildings and/or school districts and/or educational service districts in order to create, implement, and/or expand collaborative strategies between housing and education partners to promote housing and educational stability.
- Provide ways to engage and connect students, unaccompanied youth and/or young adults, and families with education enrichment activities and supports, including but not limited to tutoring, life skills, economic mobility, entrepreneurship, afterschool programming, attendance supports, and school/district community events
- Develop and implement evidence-informed strategies to address racial inequities among students and families experiencing homelessness, including unaccompanied youth, in the K-12 public school system.



School-Housing Partnership

HSSP and Homeless Student Support Education Program (HSSeP through OSPI) funds are administered by two agencies to create partnerships between housing support services and school districts:

- The goal of the programs is to encourage the development of collaborative strategies between housing and education partners.
- Work towards improve collaborations with school building and districts
- Improve services for Unaccompanied Youth experiencing homelessness.
- Need to expand or improve identification, enrollment and services.
- Housing support should aim to link students and families with stable housing located in the student's school district.

If your housing is unstable and you must move, your school can stay the same

Household Eligibility

Households served by the program must include at least one student enrolled in the public K-12 system and be:

- Meet the definition of homelessness as defined by McKinney-Vento, including unaccompanied youth.
- At or below 50% of area median income at time of program entry.
- The entire household must be considered for eligibility determination and services.





Program Requirements

- Reporting and Evaluation
 - Program data must be entered into the Homeless Management Information System (HMIS).
 - Reporting must include a narrative that describes the partnership with the school(s) or school district(s) and the quantity and types of supports offered to promote academic learning
- Memorandum of Understanding (MOU)
- HSSP Contract Template
 - Terms and Conditions
 - Insurance



Community Review Panel Breakdown

The following weighting will be assigned to the proposal for evaluation purposes:

- Ensuing equity
- School partnership
- Organization and staffing
- Program design and budget
- Geographic diversity across the state





Ensuing Equity

- Implementing community-informed strategies to address disproportionality, opportunity gaps and other systemic inequities that negatively impact students experiencing homelessness including students of color.
- Improve access to underserved/disproportionally impacted populations such as BIPOC, LGBTQ2, and individuals living with disabilities
- Increasing the capacity and support for Unaccompanied Youth experiencing homelessness.



Building Changes Appeal

- Grounds for an Appeal: Applicants may only submit an appeal on the following grounds: Failure by Building Changes to follow procedures outlined in this Request for Proposal; and/or discrimination or conflict of interest on the part of a rater.
- When to Submit an Appeal: Appeals will be considered from December 26, 2023, through January 9, 2024.
- How to Submit an Appeal: Building Changes must receive all appeals in writing during the window for appeal from December 26, 2023, through January 9, 2024. Appeals will be reviewed by the Managing Director of Programs. Appeals must be emailed to the Managing Director of Programs, Liza Burell, at Liza.Burell@BuildingChanges.org. Applicants should indicate the grounds for their appeal and a short description of why they are appealing.
- Review of an Appeal: All materials (application, score sheets, reviewer comments, supplemental materials) pertaining to the applicant along with the appeal letter will be reviewed by the Managing Director of Programs, who has the authority to have a new reviewer read and consider the application. Building Changes will have 10 business days to review the materials and provide a written decision back to the applicant.
