FROM JULY 2023 TO JUNE 2024, WE SUPPORTED SEVEN COMMUNITY ORGANIZATIONS AND TWO TRIBES, IMPACTING 146 HOUSEHOLDS, INCLUDING 212 INDIVIDUALS, THROUGH THE WASHINGTON YOUTH & FAMILIES FUND (WYFF). SINCE 2022, 962 STUDENTS, 69% STUDENTS OF COLOR, WERE SUPPORTED THROUGH THIS WORK.
